Our CREW Atlanta By-Laws state that our membership composition must be at least 75% FULL Members and 25% Affiliate. We may suspend approving Affiliate Members from time to time if we exceed these percentages.

Two (2) current CREW Atlanta member sponsors are required for each application. Affiliate Members pay a one- time administrative fee of \$200. If one or more members from the same company is currently a member, the fee is waived. There is not an administrative fee for the other categories. CREW Atlanta does not have a company rate. Our members are approved on an individual basis and the membership follows the individual. If a company chooses to swap out representatives in the current year, then the new member must complete an application and the CREW Network dues of \$180 must be repaid.
